Brother Knights,

Please keep the following Knights and their families in your thoughts and prayers. Please email or call me for any updates.

Brother Joe Nanci says, “ regarding his skin cancer, I'm pretty good, next week they going to remove the access tissue from the bridge of my nose and then some time in February they going to remove the skin cancer from the other eye, but thank GOD this one won't be as bad as the first one.”

Brother Bob DePaola took a slip and fell hard on his left knee in Dec. and wearing a soft cast for now and pain pills for the pain. He says, “I went to the Orthopedic Surgeon today (mid Jan.). He told me according to the x-rays I am not a candidate to a third orthoscopic surgery in that knee seeing I have already had two. Because of all the damage that has been inflicted on the knee during my days of police work I am now developing arthritic pain as well. He gave me a choice of either cortisone shots every three months or a complete knee replacement. I have chosen the shots. If that works that I will go with that for now. The first shot I got has seemed to work but I need to use a brace to immobilize it from twisting. Other than that I am great.”



Brother Mark Brewster had total knee replacement in early November. He says, "Coming along good, still fighting infection. Taking antibiotics. Start physical therapy the first of Feb."

Brother Bob Fiorentino says, Phyllis is half way thru her cardio rehab and continues to make positive progress

Cousin will get his third set of chemo infusions next Friday, Aside from losing his hair and the normal post infusion fatigue and discomfort he is doing OK and spirits are up. After the 4th set of shots they will assess the results so keep praying."

Brother Jim, Schrader says, "My wife, Dorothy, is now home from the hospital after a knee replacement. She is improving daily, and can walk with her cane for short distances. She has been able to get to mass now, and thanks everyone for their prayers."

Brother Keith Carden says, "I'm about the same battling this disease, CFS. Also how about including this link to a ME/CFS article in my monthly health check? This would help my brothers better understand this disease.

Brother Jack Abajian needs our special prayers regarding his Internal Cervical Fusion Surgery on Oct. 29th, he had a series of setbacks, but he was home in Dec. Received the following message from Toni dated 1-14-14. Wish I had better news to share with you. Jack (Abajian) was taken back to the emergency room last night again having respiratory failure. We are waiting for results of the CT scan they took, checking for pulmonary embolism in his heart or lungs. The

lung X-ray showed no fluid in his lungs. They are trying to understand why this keeps happening with him. Please keep him in your prayers today. I will be going to the hospital soon and will keep you all updated as soon as we know something.

Brother Jim Dawson continues to go in for dialysis three times a week. He fell in the morning, 1-16-14, paramedics got him back on his feet and off to dialysis. He came home with pain in the leg that caused the fall and is planning to go back to doctor.

Brother Jim Doyle has a prosthetic to replace the loss of his foot. He is in great spirits and getting used to it. He says he's 70 percent back to normal, almost no use of a cane. He is thankful for the prayers.
