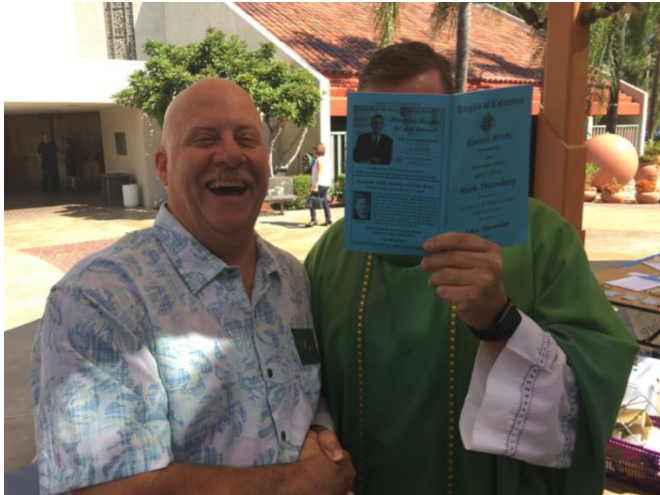

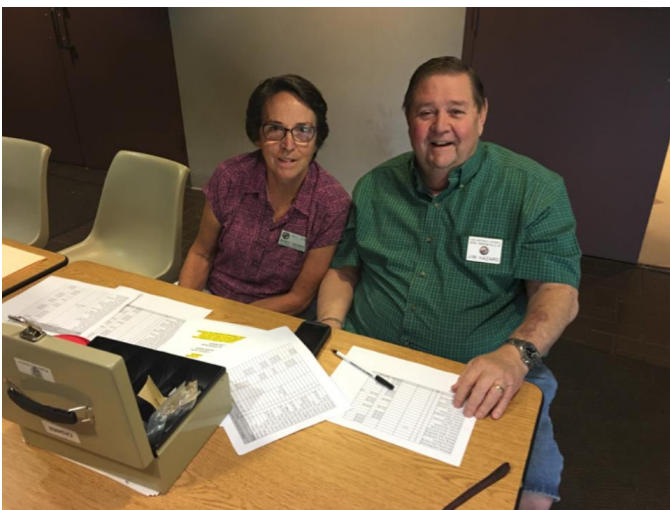
In the 10 years since its founding, GHH has rescued and restored 2,000 women; served 2 million meals; and impacted 20,000 families.

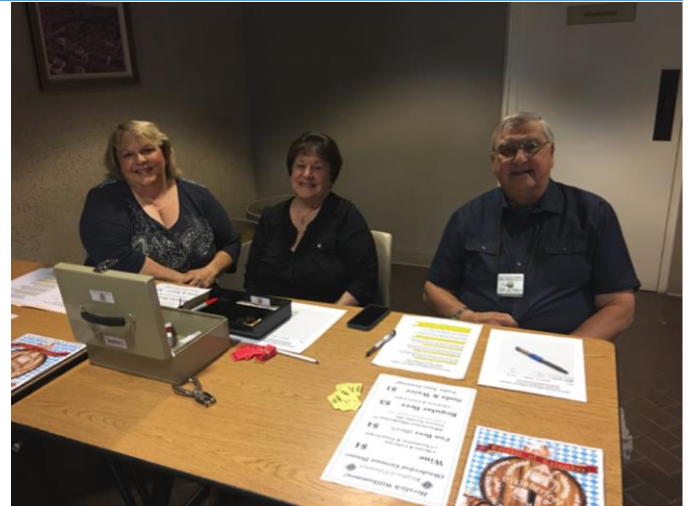

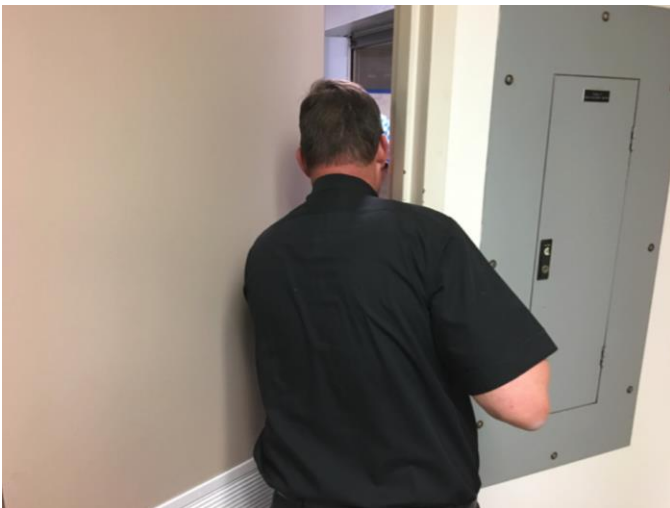

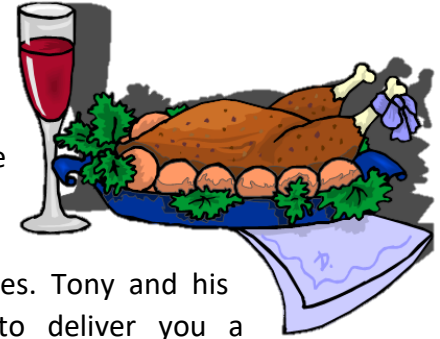
